## ADOPTION AGREEMENT FOR HORSES

LCAR is very committed to the rescue of horses and our goal is to match the right horse to the right home. We are not a sales barn or an auction yard. We want to offer a permanent, caring, FOREVER homes to those animals that have been so badly mistreated.

I \_\_\_\_\_, am applying to adopt \_\_\_\_\_ from LCAR and wish to take possession of him/her on \_\_\_\_\_ with transportation being provided by \_\_\_\_\_. I understand that if I request LCAR to haul the horse(s) for me there will be a minimum charge of \$ 40.00 (per horse) within 10 miles of our facility and additional \$ 3.00 per mile one way for anything over that.

I \_\_\_\_\_, am fully aware he/she is a rescued horse(s). Due to the circumstances involving the horse(s), I voluntarily agree to the following conditions:

\_\_\_\_ I understand the adoption is a voluntary agreement and I undertake the responsibilities without expectation of gain.

\_\_\_\_ I agree to give the horse(s) proper care, feed, shelter and any medical attention that may be needed, including regular Farrier treatments by a **LICENSED** farrier and veterinarian. Records shall be kept for all medical and farrier services given.

\_\_\_\_ I will keep the horse(s) at the "approved" location ONLY. I will keep LCAR informed of any change of address, and contact information **BEFORE** I move the horse(s).

\_\_\_\_ I understand, if I adopt a mare, I can **NEVER** breed her.

\_\_\_\_ I understand the horse(s) can **NEVER** be sold. If I no longer want or can no longer properly care for him/her I will return him/her to LCAR and no refund of any monies spent with be provided.

\_\_\_\_ I understand that if/when an adopted LCAR horse dies, it shall be reported to LCAR so the horses' file can be closed.

\_\_\_\_ I understand that if there is **EVER** an investigation opened by **ANY** Law Enforcement office, Humane Society or any other organization in reference to the care or treatment of any animal in my custody, **OR** if I **EVER** fail a property inspection, **OR** a follow up adoption inspection of the animal, that it will be immediate grounds for any animal that I have adopted from **LCAR-Equine Rescue** to be removed from my custody and returned to **LCAR-Equine Rescue** and no refund of any monies spent with be provided.

**I HAVE READ THE PROVISIONS OF THIS DOCUMENT CAREFULLY AND AGREE TO ABIDE BY ALL THE CONDITIONS SET FORTH ABOVE.**
